Leaks in stainless steel pipes at a cogeneration plant, cracks in an engine block at a methanisation unit, explosion of steam pipes at an industrial site: these incidents cause operational downtime and require an immediate response. Direct damage and operating losses can amount to several million euros.

In these contexts, where economic, technical and legal issues are at stake, insurance experts must react quickly and mobilise reliable skills to ensure their analysis is reliable. Patrick Lubszynski, Structure Expert and Head of Renewable Energy at

Stelliant Expertise, chose Cetim. *"The first requirement is responsiveness.
